This Committee responds to the 6/8/16 and 6/29/16 RFAs, with responses due 7/13/16 and 8/3/16, as follows:
Neither the Committee nor the vendor have any record of the expenditure at issue actually having been made. This amount was likely budgeted but never spent, and during the hectic startup process for a new committee, a draft report was filed in error. This report is amended to remove the expenditure, to properly reflect the fact that none was made. Also included in this amendment, and unrelated to the previous item, are a memo entry on Schedule E that was initially reported on a 24-hour report (FEC-1047928) but inadvertently excluded from the March monthly report, and an in-kind contribution from an affiliated committee of the costs of that independent expenditure. The amount of the expenditure has been updated to reflect the final amount paid.
