
Dear Mr. Buhr

You Stated that "the beginning cash balance of this report (12 Day Pre General Report) does not equal the ending balance of our amended 2020 Quarterly Report".

Please be advised that we have corrected the opening balance of the above-captioned report and filed an amended report, as requested. We discovered that we inadvertently classified certain contributions (\$5,275) received from "ACTBLUE" as conduit instead of earmark contributions, which had the effect of changing the opening balance.
