This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following  $\underline{3}$  item(s):

**1.** Your amended report discloses an increase in receipts totaling \$45,000.00 from the amounts disclosed on your original report. Please amend your report or provide clarifying information as to why this activity was not disclosed on your original report. (11 CFR § 104.3)

Although the Commission may take further legal action concerning this matter, your clarification and any additional clarification you may have will be taken into consideration. 11 CFR §104.3

**2.** Your amended report discloses a decrease in disbursements totaling \$17,837.73 from the amounts disclosed on your original report. Please amend your report or provide an explanation to clarify why this additional activity was not provided with your amended report. (11 CFR § 104.3)

**3.** Schedule A supporting Line 15 of your report discloses an offset to an operating expenditure totaling \$45,000.00 from "80-20 Educational Foundation;" however, there are \$15,086.00 in disbursements for the purposes of "staff time, e-mailing service, and e-mail list" disclosed on your disbursement schedules of your 2015 and 2016 Reports combined. Please provide clarifying information regarding this discrepancy and amend your report(s) if necessary. (52 U.S.C. §30104(b) (formerly 2 U.S.C. 434(b)) and 11
