
Dear Mr. Buhr:

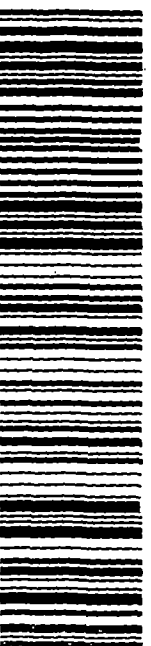
