Gentlemen:

I have received your request for additional information and am in the process of preparing an amended report. A personal situation prevented an earlier response.

The Libertarian Party of North Carolina has, for the past several years, received payments from the State of North Carolina under the state's "Political Parties Financing Fund" (PPFF). This fund was paid from tax funds under a "check-off" process that did not affect the total taxes due. Funds could be designated to any one of three parties: Democratic, Republican, or Libertarian. A donation could also be "undesignated," in which case the funds were distributed *pro rata* according to the ratio of designated funds. This public financing has now been terminated by the State Legislature.

By law, the PPFF monies are sequestered into a separate bank account and distributed to operating accounts as needed. Except for interest payments from the bank, no money is comingled.

I will provide an updated, amended form immediately.

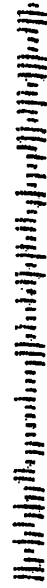
