This letter is in response to your August 27, 2008 letter regarding the Edward Jones PAC ('the PAC') July Quarterly Report (4/1/08 - 6/30/08). As we discussed last week, the 05/29/08 contribution to Rely on Your Beliefs Fund was reported as a contribution to Friends of Roy Blunt due to a clerical error. The two contributions to Texans for Senator John Cornyn should have been for the general election. One was designated for the general election, but reported as primary due to a clerical error. We requested refunds for both contributions. (See attached) However, the Cornyn organization properly recorded one contribution as a general election contribution and refunded the other.
