I am responding to your letter dated June 16, 2009. We have reviewed the two reports as they appear on the Commission's website, and the posted September 24 report at least does not correspond to what our records reflect that the United Food and Commercial Workers International Union (UFCW) filed electronically with the Commission. Enclosed is the hard-copy record that UFCW made contemporaneously with those filings, as is its practice, as well as copies of electronic acknowledgements from the Commission. For the record, on each report the candidate was John McCain, the office was President, and the election was the general election.

Your office previously inquired on April 9 about a different aspect of these filings, and we responded on May 4. We request that in reviewing a report your office send a single communication that includes all of its questions about the filing rather than sending multiple inquiries, six and eight months after the fact, that require multiple responses.
