-Commission records indicate that your committee has not made contributions to five (5) federal candidates and has not been registered for six (6) months.

If the information you provided was incompletely or incorrectly disclosed or you believe the Commission records to be in error, please submit documentation which will clarify the matter. Should your committee meet the requirements for multicandidate status in the future, please submit a new Notification of Multicandidate Status (FEC
