- Your report contains financial activity disclosed on a previous report. Overlapping coverage dates create difficulties in tracking the committee's cash flow.

Please be advised of the filing dates and coverage periods for the 2013-2014 election cycle and fill in the appropriate dates on Line 5 of the Summary Page. enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
