Thank you for your letter dated July 11, 2008 regarding the contributions that appear to be in excess of the contribution limits.

The two contributions referenced in your letter are each \$5,000 contributions made to McConnell Senate Committee '08 on 4/16/2008 and 5/5/2008. Our PAC made a mistake in reporting these both as contributions to the general election, when in fact the 4/16/2008 contribution was for the primary election. Please note that the recipient committee (C00193342), McConnell Senate Committee '08, reported the 4/16/2008 contribution correctly towards the primary election.

We have electronically filed an amended report for the month of 4/1/2008-4/30/2008 to reflect this correction. I hope you will accept this as an adequate corrective action and that this will bring the matter to a close.
