This letter is in response to your January 26, 1995
letter which attaches a December 16, 1994 letter. The
earlier letter had not been previously received in this
office or in the office of the PAC Treasurer.

We believe the reporting discrepancy discussed in your
December 16 letter occurred as a result of the change
of name of our PAC from Employees of Pacific
Enterprises PAC to Southern California Gas Company
Political Action Team ("Committee") on or about March
22, 1994. The Committee was registered as a
multicandidate committee at all times relevant to your
letters and maintained the same FEC identification
number (C00008748).


I suspect that the contribution to the Robb for Senate

Committee's former name. This would explain why the
Committee reported the contribution on its Form 3X
dated October 5, 1994, while the Robb for Senate
Committee reported the contribution using the
