Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

1. Line 6 of your Statement of Organization indicates that "S&T Bank" and "S&T Bancorp, Inc." are the connected organizations for your Committee. If your committee is jointly sponsored by these entities, the full names of these organizations must appear in the name of your committee. (See Advisory Opinions 1988-42 and 1988-14) However, if your committee is not jointly sponsored and one of these organizations represents a parent company or subsidiary of your connected organization, you need not include its name in the name of your committee. 11 CFR §102.14(c)

Please provide clarifying information concerning the relationship between these apparent connected organizations, with regard to your separate segregated fund. Your Amended Statement of Organization, received 8/1/1997 indicated that "S&T Bancorp, Inc." was the "Parent Holding Company" for your committee. If this is still correct, please amend your Statement of Organization to provide this clarifying information.


-For future reference, all Statement of Organizations filed by federal political committees must be on FEC Form 1. 11 CFR §102.2(a)(1) State or non-FEC forms are not required or acceptable. Please do not file state or non-FEC forms with the Commission.

-For future reference, please do not include the name of the Committee's Treasurer on Line 1 of your Statement of Organization.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
