
April Quarterly Report (07/1/15 -09/30/15)

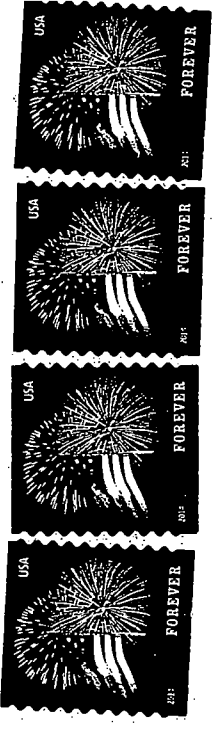
