Thank you for your letter of October 8 regarding the disagreement between our 2002 ending balance and 2003 beginning balance. I appreciate this problem being brought to my attention.

Enclosed please find an amended Mid-Year Report for our committee. It reports a beginning balance of \$ 195.66, thereby matching the 2002 ending balance reported on our 12/31/02 report. The discrepancy noted in your letter was caused by a bookkeeping error on my part. Donations received by our committee during the month of January 2003 were not properly accounted for when I compiled the Mid-Year Report. These transactions occurred during a period when we were changing both treasurers and bank accounts, so I trust you can understand my less-than-complete grasp of our financial history during that period! Happily your letter has given me the chance to clarify matters, both for the FEC and our committee.

I also call your attention to a minor correction on Page Three. The Mid-Year Report overstated our unitemized contributions by \$10.00. This amended report contains the correct figure of \$ 9,862.00.

Again, thank you for calling my attention to these items.
