1. On 11/20/09 GWI PAC refunded 45 dollars to GWI that was previously deposited twice in error into the GWI PAC federal account for the October automatic payroll deduction for Ray Goss. GWI deposited a second 45 dollars contribution on behalf of Ray Goss when it corrected an original 10/1/09 payroll processing, associated with the 10/9/09 GWI PAC 45 dollar contribution, with an adjustment made on 10/21/09. This second 45 dollar October deposit to GWI PAC on behalf of Ray Goss was made on 11/16/09, and was reversed on 11/20/09. This caused Ray Goss' YTD total to be overstated by 45 dollars. The correct YTD withholding is 540 dollars, not 585 dollars. 2. The transfer to the nonfederal account referenced under the disbursement section is intended to replenish our nonfederal account. The money is strictly used for candidate contributions at the state level.
