Dear Vicki,

This memo is in response to the RIA letter RQ-2 referencing the Hensley for Congress Amended July Quarterly Report (04/01/2012 – 06/30/2012) received 8/15/2012. The Hensley for Congress identification number is C00510404.

Regarding Item 1 referencing Schedule A, we determined the committee did not designate excess funds from the primary election to the general election for four of the individuals listed (Bough, Friedrich, Hensley, and Weaver) and the committee has issued refunds for the excess funds to these individuals.

In the case of Peters-Baker, it was determined the committee inadvertently combined the records of the individual and her affiliated campaign committee, and the \$2,500 received on 3/30/2012 was actually from her campaign committee. The committee has issued a full refund for this receipt.

Copies of these five refund checks are attached and refunds will be reported on the Post-General report covering 10/18/2012 to 11/26/2012.

Regarding Item 2 referencing Schedule A, we determined the committee did not include "a MEMO text stating that the funds were received from federally permissible sources. (11 CFR §102.5(b))" as explained in the FEC's guide to PAC contributions. The committee has clarified these receipts to be from federally permissible sources and will file an amended July quarterly report before the 11/23/2012 response date.
