- Schedule A supporting Line 12 discloses that your committee received a \$6,250 transfer from "Washington State Democratic Party"; however, a review of the reports filed by this committee discloses the disbursement of only \$3,125 (see attached). Please confirm that the full amount of \$6,250 was actually transferred to the federal account of this committee or provide additional clarifying information.



Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
