The expenditures listed as Strategic Management Services on Schedule B were not made on behalf of any federal candidates and were properly disclosed on the corresponding disbursement schedule of the report. The expenditures disclosed on Schedule B for Communications Services are not public communications or voter drive activity containing express advocacy. These expenditures were made exclusively to support the activities of VoteVets. The committee recently performed an internal audit and based on the findings it was determined that an adjustment of \$46,307.56 was needed to ensure the committee's bank balance matched the cash on hand totals disclosed to the FEC.
