Dear Ms. Senger:


Per your request, this letter addresses the circumstances regarding the \$3,000 receipt disclosed in our February Monthly Report which was the subject of your March 31, 2006 letter to me.

In the early part of 2006, Greenberg Traurig LLP ("the Firm") and Greenberg Traurig LLP PAC ("the PAC") received a number of contribution refunds from various federal and non-federal recipients. On January 20, 2006, as reported on our February Monthly Report, we inadvertently deposited two refunds which had been issued to the Firm into the PAC's bank account. These refunds came from the Linda Lingle Campaign Committee and the Great Plains Leadership Fund, two entities which received permissible non-federal contributions from the Firm, and which issued refund checks (for \$1,000 and \$2,000, respectively) made payable to the Firm. Copies of these refund checks are attached.

Due to an oversight in processing, these two refunds to the Firm were inadvertently deposited into the PAC. As soon as we became aware of the error, on February 23, 2006 – less than a month after the deposit and prior to the generation of your letter – the PAC remitted these funds to the Firm, as intended by the non-federal entities which sent the refund checks. These transactions were itemized on Line 29 of our March Monthly Report, and copies of the respective remittance checks are also attached. Furthermore, we have reviewed our procedures to ensure that such an oversight does not recur.

We appreciate this opportunity to clarify the circumstances of those transactions. If you have any further questions, please do not hesitate to contact me.


