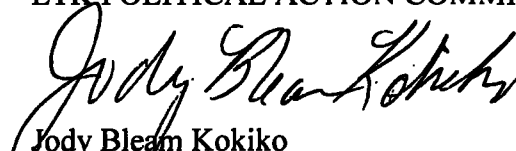
Dear Ms. Needles
