We are legal counsel to Boilermakers Local 169 and its political action fund referenced above. I am following up from our phone conversation of yesterday.


1. Enclosed is the amended report correcting lines 11(a)(i) and 11(a)(ii), Column B of the Detailed Summary Sheet.
