

Dear Sirs,

At the time of Paula Overby's original filing it was her understanding that it was necessary to register a committee Treasurer to solicit funds for a congressional campaign. Following subsequent review and her conversation with a Federal Election Commission representative, it is now her understanding that fund raising or expenditures in excess of \$5,000 should precede the F.E.C. filing. Ours is not a typical campaign and therefore we have focused on models of engagement utilizing extensive volunteer support rather than traditional models of campaign fund-raising and advertising. As a result of the upcoming April 15th filing date, this letter is to notify you that we have not yet exceeded the \$5,000 threshold.
