The Scott Brown for U. S. Senate Committee (C00467233) is in receipt of your Request for Additional Information dated June 22, 2011, regarding our Amended April 2011 Quarterly Report.

The Committee filed an amended FEC Form 1 on June 24, 2011 to disclose Commonwealth Cooperative bank as an additional depository.

The reported disbursement to Neil C. Gordon on Line 21 was not related to an excessive contribution from a donor, nor to a contribution that was impermissible under Commission regulations, but instead was based on a request for a return of funds in connection with a Court Order. The Order arose from a legal action, involving a donor, which was unconnected to the Committee. The committee voluntarily complied with the request. Accordingly, the transaction was correct as originally reported.
