I am writing on behalf of the Texas Freedom Fund (the "Committee") in response to questions raised by you concerning information contained in the Committee's Mid-Year 2001 Report for the period January 1, 2001 through June 30, 2001 (the "Report").

1. Administrative Expenses

The Committee properly disclosed payments for the limited number of administrative and operating expenses that it had during the January 1 through June 30, 2001 reporting period. The Committee does not have rented office space and it uses a post-office box for receiving mail. The Committee's report discloses payments to a person who provides various accounting services, including: processing contributions, depositing funds, paying expenses, preparing FEC reports, and handling other day-to-day items for the Committee. During this period, a fundraising consultant was hired as an independent contractor to raise funds for the Committee. The Committee's Report also discloses payments to a law firm to review legal matters that arise from time to time. In addition, some individuals volunteer their personal time to assist the Committee.

2. Schedule B for Line 23 – Office Sought Information

The Committee has amended Schedule B for Line 23 to include the office sought by the candidates to whom the Committee made contributions during this reporting period.


3. Treasurer's Name on Electronic Reports
