Enclosed are the Amended FEC Report Pages covering the activities of the Philip Morris Companies Inc. Political Action Committee (PHIL-PAC) for the period January 1, 1999 through June 30, 1999. This action is in response to the following two letters from your office, both dated December 15, 1999:

Reference: Mid-Year Report (1/1/99-6/30/99)

Reference: Amended Mid-Year Report (1/1/99-6/30/99), dated 8/10/99

Pages included for this amended report are as follows:

**Line 22** of the Detailed Summary Page discloses \$65,000.00 in transfers to affiliated committees. I am resubmitting page 2 of schedule B for line 22. It indicates an additional \$10,000.00 in transfers which when added to page 1 (\$55,000.00) would give us the correct total.

**Line 23** of the Detailed Summary Page discloses \$206,366.00 in contributions to federal candidates and committees. I am resubmitting pages 1-20 of that report which total \$119,400.00 in contributions. The \$119,400.00 plus the \$86,966.00 that you indicated brings us to the correct total of \$206,366.00.

**Line 29** indicates \$2200.00 in other disbursements. In Schedule B for line 29 we incorrectly indicated \$4000.00 because our software did not pick up the negative disbursements. I am enclosing a corrected schedule B for line 29 for your review. I have also contacted the software company and have asked them to correct that problem for the future.

**For Line 11 (a) (i)** I am resubmitting pages 81, 93, 102, 104, and 105. The sum of these pages total \$6243.78 which when added to the \$169,368.21 you indicated, brings us to the correct total of \$175,611.99.
