Dear Mr. Fortkiewicz:

This letter is responsive to your letter to me dated July 5, 2015, wherein you indicated the entire name of our connected organization "Manufactures & Traders Trust Company" must be included in the name of our political committee. Please be advised that we have filed an amended Statement of Organization, FEC Form 1 for the M&T Bank and Wilmington Trust Political Action Committee (the "M&T Bank PAC") amending Section 6 to change the name of the connected organization to M&T Bank instead of Manufacturers and Traders Trust Company. For your convenience, I am enclosing a copy of that filing.

As evidence of the legal name "M&T Bank", I am enclosing a copy of the M&T Bank Restated Organization Certificate filed in the State of New York Banking Department. Paragraph 1 of the Restated Organization Certificate on Page 2 indicates that the name of the organization is Manufacturers and Traders Trust Company or M&T Bank. I am also enclosing a letter dated September 9, 2004 from the New York State Banking Department indicating that Manufacturer and Traders Trust Company is to be known by both the names "Manufacturers and Traders Trust Company" and "M&T Bank" effective September 9, 2004. The Banking Department has authorized the legal name of the bank to be M&T Bank.

Cofsky, Deputy Superintendent of Banks of the State of New York, DO HEREBY APPROVE the annexed Certificate entitled "RESTATED ORGANIZATION CERTIFICATE OF MANUFACTURERS AND TRADERS TRUST COMPANY UNDER SECTION 8007 OF THE BANKING LAW," dated February 2, 2011, to restate and amend by deleting, in its entirely, Article 7, relating to certain restrictions on amending the corporation's Bylaws or this related organization certificate, which article has terminated as a result of the termination of certain provisions of the Bylaws; and have caused the filing of said Certificate in the Office of the Superintendent of Banks on March 17, 2011.

RESTATED ORGANIZATION CERTIFICATE

OF

MANUFACTURERS AND TRADERS TRUST COMPANY UNDER SECTION 8007 OF THE BANKING LAW

The undersigned, being respectively, the President, and an Assistant Secretary, of Manufacturers and Traders Trust Company, pursuant to Section 8007 of the Banking Law of the State of New York, do hereby restate, certify and set forth as follows:

- (1) The name of the corporation is Manufacturers and Traders Trust Company. The name under which the corporation was originally incorporated was The Fidelity Trust and Guaranty Company of Buffalo.
- (2) The organization certificate of the corporation was filed in the Office of the Superintendent of Banks of the State of New York on September 13, 1892, and in the Office of the Clerk of Erie County, New York on September 14, 1892, and the certificate of authorization of the Superintendent of Banks of the State of New York was issued on June 27, 1893.

A first restated organization certificate of the corporation was approved and filed in the Office of the Superintendent of Banks of the State of New York on August 6, 1954. Such restated organization certificate was amended from time to time thereafter. A second restated organization certificate of the corporation was approved and filed in the Office of the Superintendent of Banks of the State of New York on February 26, 1991. A third restated organization certificate of the corporation was approved and filed in the Office of the Superintendent of Banks of the State of New York on May 22, 1992. A fourth restated organization certificate of the corporation was approved and filed in the Office of the Superintendent of Banks of the State of New York on April 1, 2003. A fifth restated organization certificate of the corporation was approved and filed in the Office of the Superintendent of Banks of the State of New York on September 9, 2004.

(3) The restated organization certificate is hereby restated and amended by deleting, in its entirety, Article 7, relating to certain restrictions on amending the

corporation's Bylaws or this restated organization certificate, which Article has terminated as a result of the termination of certain provisions of the Bylaws.

(4) The text of the corporation's organization certificate, as amended heretofore, is hereby restated without further change to read as hereinafter set forth in full:

"ORGANIZATION CERTIFICATE OF MANUFACTURERS AND TRADERS TRUST COMPANY

- 1. The name by which the said corporation shall be known is Manufacturers and Traders Trust Company or M&T Bank.
- 2. The place where the principal office of the corporation is to be located is the City of Buffalo, County of Erie and State of New York.
- 3. The amount of the corporation's capital stock is \$200,000,000. The number of shares into which such capital stock shall be divided is 5,000,000 common shares of the par value of \$40 per share.
- 4. The number of directors which the corporation shall have shall be not less than seven (7) nor more than thirty (30).
 - 5. The term of existence of the corporation shall be perpetual.
- 6. The corporation shall exercise the fiduciary powers conferred by Section 100 of the Banking Law, as amended from time to time, in addition to the other powers conferred upon banks and trust companies pursuant to the Banking Law or other applicable law."

(5) This restatement of the organization certificate was authorized pursuant to Section 6015 of the Banking Law by the written consent, setting forth the action taken, of the holder of all of the outstanding shares entitled to vote thereon.


