Dear Ms. Daughtrey:

I am writing in response to your letter of February 20, 2009, a copy of which is enclosed. The discrepancy between our ending cash balance on the 10/1/08-10/15/08 report and the beginning cash balance on the 10/16/08-11/24/08 report was a result of an error I made in electronically filing amended reports for these periods on January 29, 2009.

The correction which resulted in the amended reports actually took place in the 10/1-10/15 time period, but I failed to upload the amended report for this time period on January 29. I did upload both the amended report for10/16-11/24 and an original report for 11/25/08-12/31/08 at that time. I uploaded (and officially filed electronically) the amended report for 10/1-10/15 earlier today, correcting the discrepancy in cash balances. A current summary of our filings for the second half of 2008 is shown below.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. - 1. The beginning cash balance of this report should equal the ending balance of your 12 Day Pre-General Report (10/01/08 10/15/08). Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
- 2. The totals listed on Lines 6(c), 11(a)(ii), 11(a)(iii), 11(d), 19, and 20, Column B of the Summary and Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to

taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
