Loan Agreement And Promissory Note

Whereas:

A. the Pro-Life Victory Federal Political Action Committee (hereinafter referred to as Borrower) has need of start-up funds in the amount of \$5000; and

B. Marion B. Weyna (hereinafter referred to as Lender) is willing to lend Borrower \$5000 without interest, subject to the following terms and conditions:

1. Borrower agrees to return to the Lender the \$5000, in a lump sum or in \$1000 increments, anytime during three years from the date on which the signatures are affixed hereon; and

2. Borrower agrees to pay Lender a penalty of 10% of the unpaid balance per annum if the loan is not paid in full by the end of the three year loan period; and

3. The Treasurer and Assistant Treasurer of the Borrower shall be responsible, each and severably, for any default of the loan; and

4. All parties to this agreement agree to use their best efforts to guard the anonymity of the Lender.


