Dear Ms. Eger:

In response to your letter dated April 17, 2009; the contributions to Friends of Byron Dorgan are allocated as follows:

-check dated 09/25/2007 in the amount of \$5,000 should reflect 2010 Primary Election (as your letter states)  
-check dated 11/20/2008 in the amount of \$2,500 was reported by the Dorgan committee as the 2010 General Election although we requested 2010 Primary. Upon our discovery of this discrepancy we re-designated this check on our 2009 February monthly filing to reflect the same election as the recipient committee. This being said, there will be no redesignation request that we can provide.  
-two checks dated 12/19/2008 in the amount of \$2,500 each, one designated toward the 2008 Primary and one designated toward the 2008 General Election were returned to us and voided; these voids also appears on the 2009 February Monthly filing

The 2009 February Monthly filing should reflect that the FedExPAC has met but not exceeded the \$5,000 per election limit to the campaign committee for Senator Byron Dorgan.

With regards to the check issued to Alaskans for Begich in the amount of \$5,000 being designated towards 2008 debt retirement; we have been informed by the Alaskans for Begich Committee that they have amended their FEC filings to show they had debt to retire. We will be receiving a letter from them and will forward a copy of that letter upon receipt.
