
I write as counsel to Americans for Responsible Solutions PAC ("the Committee"), Commission identification no. C00540443.

As part of a routine audit of its books and records, the Committee discovered that its reported cash-on-hand does not match that reflected on the Committee's bank records. As a result of this finding, the Committee engaged consultants with significant experience filing reports with the Commission, and has devoted considerable time and effort to explain the discrepancy. These efforts have been successful.

The Committee has adjusted its cash-on-hand figure by including a cash correction entry on Line 29 of its Year-End Report due on January 31, 2016. Attached to this letter is a schedule detailing each of the corrections comprising this adjustment.
