Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in enforcement action.** Additional information is needed for the following 1 item(s):

- A review of the reports filed by Mortgage Bankers Association Political Action Committee (MORPAC) discloses a \$5,000 contribution made by your committee on 12/6/17. However, your reports do not appear to disclose a disbursement to this committee. Further, a miscellaneous electronic submission filed by this committee on 3/22/18 states "This report is in response to the RFAI sent to Mortgage Bankers Association Political Action Committee (MORPAC) (C00004812) on March 20th 2018. In said RFAI it was stated that we disclosed receipts from SOUTHWEST BUSINESS CORPORATION PAC (SWBCPAC) that were not also disclosed by the giving committee. We have deposit slips and check facsimiles in our records showing we received check number 1067 dated 11/30/2017 made out to our Federal PAC (MORPAC) in the amount of \$5000. We believe this may not have been properly disclosed by the disbursing committee." Please amend your report(s) to disclose this activity or clarify this apparent discrepancy.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will**
