

In response to your letter to Daniel L. Warner, Treasurer, Crowley Maritime Corporation Federal PAC, dated August 19, 2011 requesting further information relating to Schedule A and Schedule B of the above-referenced report, please note the following clarifications:

1. Schedule A – After speaking with your office, we were able to determine that we had incorrectly reported items on line 17. We submitted an amended report to your office electronically on August 25, 2011. The receipts on line 17 totaling \$5,910 included \$5,150 in individual contributions which we have itemized by contributor in the amended report. The remaining \$760 in receipts were anonymous contributions below the \$50 limit as defined in chapter 2, section 3, page 15 of the Political Party Committee manual as revised July 2009 and are reported on line 11 (a)(ii) in the revised report.
2. Schedule B - Due to a software problem, the contribution payee was left blank on the report. We have amended the report to indicate the correct payee on the report filed electronically on August 25, 2011.

Notations as to the changes that were made are stated in the comments section of the amended report. Attached is a copy of the amended report for your reference.
