Per our telephone conversation yesterday, April 14, I am enclosing a copy of our association's March 25 letter which your records indicate was never received, or at least, is not on file. This lost communication prompted a follow-up letter of April 10 from Mr. John D. Gibson, Assistant Staff Director of your division.

The enclosed responds to your stated concerns about excess contributions from NARFE-PAC to Senator Paul Wellstone (D-MN), specifically a \$3,000 contribution in January 1991, and a \$5,000 contribution in October 1996. As noted in our earlier letter, this January 1991 contribution was debt retirement for the 1990 general election, while the more recent contribution was for the 1996 general election.

Also enclosed are copies of the disbursement records cited.

Dear Mr. Dodson:

This is in response to your letter of March 19, concerning the appearance of an excess contribution by NARFE-PAC to a candidate for federal office, in this case Senator Paul Wellstone (D-MN).

The noted records indicate a \$3,000 general election contribution on January 25, 1991, followed by a \$5,000 general election contribution on October 23, 1996. The amounts and dates of these contributions are correct. However, the January 25, 1991 contribution of \$3,000 was designated as a "debt retirement" contribution for the 1990 general election, while the October 23, 1996 contribution of \$5,000 was for the 1996 general election.

I trust this information will serve to correct the record, as well as any appearance of excess contributions from NARFE-PAC to Senator Wellstone.
