To whom it may concern,

I am writing to forgive the debt incurred by Alden Smith for Congress (C00544965) from Alden Smith.

The campaign, Alden Smith for Congress incurred a total of 60,000 USD of debt over two loans issued to the campaign by the candidate Alden Smith. These loans included 10,000 USD on the date of 10 April 2013 as recorded on the July Quarterly Report (FEC Form 3, Schedule C p. 8 of 8) and 50,000 USD on the date of 30 December 2013 as recorded on the 2013 Year End Report (FEC Form 3, Schedule C, p. 24 of 24).

The campaign partially repaid these debts on 22 April 2014 by repaying the candidate 37,378.09 USD by means of a funds transfer. This transfer is documented as a disbursement on the Termination Report (FEC Form 3, Schedule A, p. 5 of 7) and in a letter from the bank to the candidate describing the transfer. A copy of that letter is enclosed.


As the originator of these loans I, Alden Smith, wish to forgive Alden Smith for Congress the outstanding balance on these loans of 22,621.91 USD.


