Pursuant to your letter dated February 15, 2006, and a conversation with Katrina Senger at the FEC on February 27, 2006, the Florida Association of Mortgage Brokers filed an amended Year End Federal PAC Report February 28, 2006. Please refer to the enclosed copy of your letter.

Dear Nancy,

The Florida Association of Mortgage Brokers recently was notified of an in-kind reporting discrepancy in regards to the reception held in your honor at our annual convention held this past July. FAMB incorrectly reported the reception as a disbursement for the general election instead of the primary election. Today I spoke with Katrina Senger at the Federal Election Commission. Ms. Senger informed me that in-kind contributions (such as food, beverages, printing or mailing) made before the primary must be listed as primary election disbursements. That is, unless the contribution is equipment, such as computers, with long-term useful life (e.g., an election cycle, or perhaps longer). Therefore, we will have to file an amended report listing the in-kind contribution for the primary election. Please modify your reporting to show the change.

In addition, FAMB will have to amend the \$5,000 contribution made to you in July of 2005. The contribution was originally reported as primary election, but will now be general election. Because we have to amend the in-kind contribution to primary, the reporting will put us over our allowed contributions per election. Please be sure to reallocate the \$5,000 as general election funds.

A copy of the letter from the Federal Election Commission is enclosed.
