
Your March 30, 1998, response is incomplete because you have not provided all the requested information. For this response to be considered adequate, the following information is still required.



Dear Ms. Hurd:

Please find enclosed two (2) amended reports and a previous letter I sent to you outlining the details of an in-kind contribution for an event for the "Friends of Roy Blunt" on November 25, 1997. I am submitting these two amended reports because of being presented with a bill for the November 25 event. The result of this bill would increase the in-kind contribution from \$2661.38 to 2956.93. Therefore, I have amended the Schedule B, Detailed Summary page and the FEC Form 3X for the year ending December 31, 1997. The change also affected the most recent filing of the FEC Form 3X for the April 15, 1998 Quarterly Report.
