Dear Ms. Benitz:

Thank you for your letters of March 26 and April 2, 2003, regarding the Commission's preliminary review of certain reports of the Dorsey National Fund. We appreciate your bringing the items raised to our attention and we are filing amended reports to address the questions in your letters.

We believe that the administrative expenses of the Dorsey National Fund are de minimis. However, in order to respond fully to your question, the Fund will purchase administrative services and will report payments for those services. As your letter suggests, for the reporting periods prior to payment for the administrative services, we will amend the reports cited to show a debt on Schedule D.

We appreciate your pointing out the requirement to report as a memo entry on Schedule A the value of legal and accounting services received for purposes of ensuring compliance with the Federal Election Campaign Act, even though such services are, by definition, not a contribution to the committee. We will correct this by amendment to the reports cited in your


