Dear Ms. Sugarman:

This letter responds to the FEC letter dated September 29, 2014 to Gun Owners of America, Inc. ("GOA") regarding GOA's July 15 Quarterly FEC Form 5 Report (4/1/14 through 6/30/14). I prepare required FEC Forms 5 and other reports, and file them with the FEC on behalf of GOA, and have done so since 2010.

1. A 24-Hour Report was filed on June 12, 2014 covering the period from 6/10/14 through 6/10/14 for an independent expenditure for Robo calls in support of a candidate made on June 10, 2014, which was the date of public dissemination. This 24-Hour Report should have been filed by June 11, 2014. The reason that this 24-Hour Report was filed late is that, although I was told about this independent expenditure in the late afternoon of June 11, 2014, I understood at that time that the Robo calls were to be made on the evening of June 11, 2014. When I contacted the vendor by telephone in the morning of June 12, 2014 to confirm the day of the Robo calls, I was told by the vendor that the Robo calls were, in fact, made on June 10, 2014. Immediately after finding out that the Robo calls were made on June 10, 2014, I filed the required 24-Hour Report on the morning of June 12, 2014. This 24-Hour Report was filed approximately 12 hours late. I note that this independent expenditure made on June 10, 2014 was reported correctly in the July 15 Quarterly FEC Form 5 report (4/1/14 through 6/30/14) filed on July 15, 2014.

2. A 24-Hour Report was filed on June 21, 2014 covering the period from 6/20/14 through 6/20/14 for an independent expenditure of radio ads in support of a candidate starting on June 20, 2014, which was the date of public dissemination. When I was preparing the July 15 Quarterly FEC Form 5 report (4/1/14 through 6/30/14), I was told in the late afternoon of July 14, 2014 that two additional independent expenditures were made on June 20, 2014 -- one was for Robo calls in support of one candidate made on June 20, 2014 (date of public dissemination), and the other was for Robo calls in support of another candidate made on June 20, 2014 (date of public dissemination). As I previously filed (on June 21, 2014) a 24-Hour Report covering the period from 6/20/14 through 6/20/14, I filed on July 15, 2014 an

amended 24-Hour Report covering the period from 6/20/14 through 6/20/14, which included these two additional independent expenditures which were made on June 20, 2014. I note that all three independent expenditures made on June 20, 2014 were reported correctly in the July 15 Quarterly FEC Form 5 report (4/1/14 through 6/30/14) filed on July 15, 2014.
