The disbursements disclosed on Schedule B for Line 21(b) of your report appear to be in-kind contributions to a candidate for federal office. In-kind contributions should be properly disclosed on a separate Schedule B, supporting Line 23 of the Detailed Summary Page. Please provide an amendment to clarify the proper disclosure of these transactions. In addition, please note that partisan communications to your restricted class may be directly funded by your connected organization.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. 
