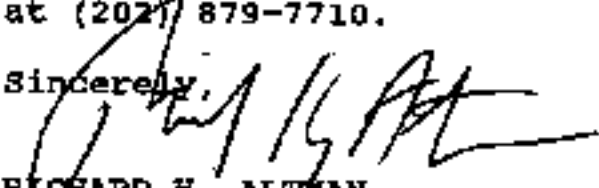
Dear Mr. Weidman:
