Dear Mr. Ng:

This is in response to your letter of February 10, 1999, and the enclosed cited disbursement schedules, indicating a contribution to the 1998 primary election campaign of Charles Schumer (D-NY) on October 20, 1998, more than a month after the September 15, 1998 primary election.

Our PAC did disburse \$5,000 to Senate Candidate Charles Schumer (D-NY) on October 20, 1998, but the disbursement was itself properly designated as "Primary Debt Retirement", although our cited 30-Day Post-General Report (10/15-11/23/98) failed to note this item as debt retirement. I would ask that this letter be used to correct our report. If that is not possible and an amended return is required, please so advise me as soon as possible of the need for such.

I trust that this information is helpful to you, but if additional information is needed, please feel free to contact me. We regret our failure to fully designate the disbursement in question as primary debt retirement.
