Response to FEC Letter of June 25, 2013 requesting additional information for the February Monthly Report (01/01/2013 - 01/31/2013): The referenced Report has been amended with a corrected Schedule H1 to reflect proper fixed percentage for allocated federal and non-federal administrative costs. In addition, Schedule H1 for each of the Reports going forward have also been amended. The non-federal share for this Report has changed from \$46,991.98 to \$43,674.90, and the difference of \$3317.08 has been transferred from federal account to non-federal account (confirmation #0716130013). The change in non-federal share for March Monthly Report was from \$68,013.24 to \$63,212.34. However, only \$32,000 was transferred for that period. Change in non-federal share for April Monthly Report was from \$70,124.37 to \$65,174.45. However, only \$35,000 was transferred for that period. Beyond the April Report, there have been no non-federal transfers.
