This is in response to your request for additional information regarding the above referenced report.


The DCCC has disclosed all contributor information that has been made available and we have used our Best Efforts to obtain any missing information. We follow the Best Efforts procedures as stated in the Campaign Guide. In our original solicitation we inform the contributor of the federal law reporting requirements and clearly and conspicuously request the contributor name, address, employer and occupation for all contributions in excess of \$200.00. If any information is still missing when a contribution is received, we send a separate follow-up letter to request the missing information and inform them again of the federal law reporting requirements. With the letter we include a pre-addressed, postage paid return envelope. When any subsequent FEC reports are filed, we include a Schedule A Memo Entry which lists all the information we have received back at that point.

The DCCC discloses gross attributable received from Majority 2000 on an on-going basis each reporting period. The DCCC-Contributions Committee was established during the Year-End reporting period (7/01/99-12/31/99). Please refer to the DCCC-Expenditures Committee (C00000935) reports to get an assessment of net transfers and gross attributable received from

Majority 2000 as of June 30, 1999. Collectively, the amount of transfers for the entire year from Majority 2000 is \$552,595.99. The total federal receipts listed on the DCCC-Expenditures Committee report, line 11a and line 11c attributable schedules total \$632,797.50. The total federal itemized receipts listed on the DCCC-Contributions Committee report, line 11a attributable schedules total \$51,925.00. Therefore, the total federal gross receipts reported for both committees total \$684,722.50 on the attributable schedules for the entire calendar year.
