
Dear Mr. Vuong:

In response to your Request for Information of August 27 (Request), the Arnold & Porter LLP Partners PAC (Partners PAC) respectfully submits the following explanation as to why the June report submitted on 6/18/10 appeared to disclose contributions which exceed the legal limits.

As your Request states, 2 U.S.C. §441a(a) prohibits a multicandidate committee and its affiliates from making a contribution to a candidate for federal office in excess of \$5,000 per election. The contributions in question, both made to the Ike Skelton for Congress Committee, total \$7,500. A contribution of \$2,500 was made on 4/22/09 and a second contribution of \$5,000 was made on 5/25/10. Schedule B of both the Partners PAC's 2009 May Monthly and 2010 June Monthly reports do not disclose the contributions as designated to a specific election. The Partners PAC has amended our 2010 June Monthly Report to designate \$2,500 of the 5/25/10 contribution to the 2010 Primary Election and the remaining \$2,500 to the 2010 General Election, thus satisfying the contribution limits set out in 2 U.S.C. §441a(a).

The Partners PAC regrets that this information was not disclosed in the original reports. The Partners PAC has also amended our 2010 August Monthly Report to designate the election of contributions to the Van Hollen for Congress Committee which may similarly appear to exceed contribution limits.
