Each year, Democratic committees from Rockingham County and Harrisonburg City work together on a fundraising banquet. Supporters from both locations come together for dinner, political speeches, a fundraising auction, and other entertainment. Funds are derived from tickets to the banquet and auction purchases. All accounting for the event is handled by the Harrisonburg Democratic Committee in acccordance with the rules of the Virginia Demoratic Party. Approximately one month after the event, Harrisonburg transfers 50% of the net proceeds (receipts minus disbursements) to Rockingham, along with records of individuals who made contributions (for seats and for auction items) and individual disbursement for the banquet. These records are retained by Rockingham and Harrisonburg. All contributors noted in these records are federally permissable for donating to campaigns, and the list is available for inspection by the FEC, if desired.
