This is in response to your letter dated April 24, 1996 regarding NASCAT PAC's Year End Report (7/1/95-12/31/95).

On March 2, 1995, NASCAT PAC made a contribution to the John D. Dingell Committee for the 1996 Primary in the amount of \$1,000. On November 17, 1995, NASCAT PAC made a second \$1,000 contribution to the 1996 Primary.


