Dear Mr. Hammon:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Your report discloses a total of \$3,190 in disbursements to "N.A.W.G" for "Transfers of funds deposited in error in PAC account" (pertinent portion(s) attached). 2 U.S.C. §441b prohibits a corporation or labor organization from contributing or expending funds for the purpose of influencing any federal election, except that a connected organization may pay for the solicitation and administrative costs of its separate segregated fund.

Please amend your report to clarify the nature of the transaction(s) in question and provide the date of the original deposit in your account. If the funds were deposited in your committee's account in error, the original receipt must also be disclosed on Schedule A supporting the appropriate line of the Detailed Summary Page on an amended report covering the period during which the receipt occurred. Although the Commission may take further legal action concerning this matter, your prompt action will be taken into consideration.

-On Schedule A supporting Line 11(a)(i), your committee disclosed a contribution(s) with an aggregate year-to-date total(s) which is greater than the total receipts disclosed from this "None/Unknown" source (pertinent portion(s) attached). Receipts from individuals/persons that aggregate

greater than \$200 in a calendar year should be properly itemized on a Schedule A supporting Line 11(a)(i), while receipts from individuals/persons aggregating less than \$200 in a calendar year should be placed on Line 11(a)(ii) of the Detailed Summary Page. Please provide clarifying information or amend the report covering the period during which the omitted transaction(s) occurred.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
