The Vermont Democratic Party (VDP) recognizes that the Federal Election Commission requires the committee to report the name, address, occupation and employer of individuals whose contributions exceed \$200 in a calendar year. In the spirit of transparency, the VDP has chosen to disclose all of our donors, whether or not their contributions aggregate to \$200 in a calendar year. The VDP may continue to report unitemized contributions from our joint fundraising partners with Dollars for Democrats and the State Party Victory Fund. Below please find the full text of the resolution unanimously approved by the Vermont Democratic State Committee on March 10th, 2012. -----

----- WHEREAS, elections in the United States and in Vermont have become increasingly affected by the expenditure of money and resources from sources that are not currently required to disclose the source of their funds; WHEREAS, the 2010 mid-term federal election was the most expensive ever, costing approximately \$4 billion compared to the mid-term elections of 2006 which cost \$2.6 billion. Figures compiled by the non-partisan Center for Responsive Politics indicate \$293 million came from groups operating independently of the candidates or political parties. Those groups, known as "super PACs," "527 organizations," and "501 (c) organizations," were free to spend without limits and accept unlimited donations from corporations, trade associations and unions. WHEREAS, half of the independent money, or \$138 million, came from 501 (c) groups that are not required to report their donors and millions of dollars more were spent by 527 organizations that have reported their spending to the Federal Election Commission without disclosing their donors. WHEREAS, secret spending has a dramatic impact on election results. For example, in seats that changed party affiliation in 2010 independent groups spent an average of \$764,000 on behalf of the winner and just \$273,000 on behalf of the loser, according to figures compiled by Public Citizen. WHEREAS, the Vermont Democratic Party supports full transparency in the financing of political campaigns and believes that free speech does not mean freedom to hide the identity of the speaker and that doing so does not increase, but diminishes the quality of political debate; WHEREAS, the Vermont Democratic Party is required to make regular filings of contributions with the Federal Election Commission but is not required to disclose the identity of donors contributing less than \$200 per calendar year to the Vermont Democratic Party; WHEREAS, the Vermont Democratic Party is required to make regular filings with the Vermont Secretary of State but is not required to disclose the identity of donors contributing \$100 or less per election cycle to the Vermont Democratic Party; WHEREAS, leadership on the issue of campaign finance disclosure and reform is a priority for the Vermont Democratic Party; BE IT HEREBY RESOLVED, that the Vermont Democratic State Committee directs that all filings of the Vermont Democratic Party reporting contributions that are made with the FEC and/or the State of Vermont must from this date forth include the identity of all donors who make contributions to the Vermont
