Dear Treasurer:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 7 items:

1. The totals listed on Lines 6(c), 7, 11(a)(i), 11(a)(ii), 11(a)(iii), 11(d), 19, 20, 21(a)(i), 21(a)(ii), 21(b), 21(c), 22, 30(b), 30(c), 31, and 32, Column B of the Summary and Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.
2. The beginning cash balance of this report should equal the ending balance of your November Monthly Report (10/01/07 – 10/31/07). Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.
3. The outstanding balance of a debt owed to a creditor at the close of one report should be exactly the same as the outstanding balance beginning the period of the next report. This report shows a beginning outstanding balance(s) to "FLS Connect", "Certified Property", "Eagle Teleconferencing", and "IN Compliance Inc.", which is not identical to the ending outstanding balance(s) for the creditor(s) on the November Monthly

Report (10/01/07 – 10/31/07). Please amend your report to clarify the discrepancy.

4. Your report discloses an outstanding balance(s) beginning this period for a debt(s) owed to "Langdon, Amy", "Direct Mail Systems, Inc", "Office Depot", "Oregon Department of Revenue", "Smith, Belinda", "South Salem Mini Storage", "Electric Lightwave", "Hoar, Kevin", "Eagle Teleconferencing", "Eschelon Teleco (Advanced Telecom)", "Internal Revenue Svc-Payroll Tax Dept.", "Lynx Group Inc.", "Smith Barney Investments", "World Trade Center & Catering", "Williamson, Janice", "Brienne Hyder". However, an outstanding balance(s) at the close of the period was not disclosed on your November Monthly Report (10/01/07 – 10/31/07). Please amend your report(s) to clarify this discrepancy.

5. Your amended report discloses additional debts totaling \$57,965.75 on Line(s) 10 of the Summary Page that were not disclosed on your original report. Please provide clarifying information as to why this activity was not disclosed on your original report. 11 CFR §104.3

6. On Schedule H4, your allocated activity or event year-to-date total calculations for the Administrative category are incorrect. Allocated activity or event year-to-date totals for administrative, voter drive, exempt activity costs and expenses for public communications made by PACs referencing only political parties are derived by aggregating all disbursements during the calendar year for each separate category. Allocated activity or event year-to-date totals for fundraising and direct candidate support activities are derived by aggregating all disbursements during the calendar year within a specific event. These should be calculated by adding the latest disbursement for a category or event to the previous event year-to-date total for that category or event. This running event year-to-date total should be disclosed after each disbursement is listed. Please amend your report by providing the correct event year-to-date totals.

7. Itemized disbursements must include a brief statement or description of why the disbursements were made. Please amend Schedule(s) B and H4 of your report to clarify the following description(s): "Larry Dennis is the Author" and "Payment on Original Debt". For further guidance regarding acceptable purposes of disbursements, please refer to 11 CFR §104.3(b)(3).

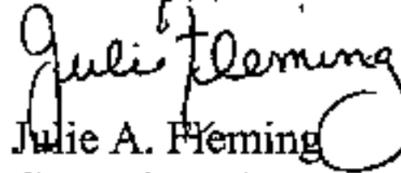
**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action

will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
