On 12/5/2021, the committee received a contribution through ActBlue from Kyle Ferari-Munoz in the amount of \$2500. As this donor had previously contributed \$5000 to the federal PAC for the 2021 calendar year, the \$2500 needed to be refunded. On 12/10/21, the contribution was refunded through ActBlue. However, while ActBlue has refunded the contribution to the donor, the \$2500 refund was not withdrawn from the committee's bank account. Instead, ActBlue is holding contributions made to the committee until \$2500 is received, and the deficit balance with ActBlue is eliminated. The committee asked ActBlue if it could send a payment for \$2500 to ActBlue to eliminate the deficit, but ActBlue refused. Per a conversation with the committee's FEC analyst on 1/28/22, the committee is still reporting the contributions made through ActBlue, even though those contributions are not being forwarded to the committee. In addition, the committee is reporting an offsetting disbursement to ActBlue on Schedule B, line 21b until there are \$2500 in contributions made to the committee through ActBlue.
